SUBJECT: CITY TREASURER'S MONTHLY INVESTMENT REPORT FOR MAY 2021

SUMMARY OF THE MATTER

BACKGROUND

The City Council delegated the investment authority to the City Treasurer and directed her to prepare a monthly report for the investments in accordance with the Investment Policy and California Government Code 53646. Accordingly, the report (Attachment 1) is presented at a public meeting and is available to the public on the City of Laguna Beach website.

CERTIFICATION

As of May 31, 2021, the cash and investment portfolio increased \$800,000 resulting in a total investment balance of \$125.4 million. The portfolio complied with the Investment Policy that was adopted by the City Council on December 8, 2020 and the related California Government Code. There is sufficient liquidity to meet the City's forecasted expenditures for the next six months.

SUMMARY

The investment objectives were established in policy in the following order of priority:

Safety: Market volatility and the economic hardships that were caused by the pandemic and the subsequent return to a post-pandemic environment were mitigated by investing in high quality securities. Credit risk was mitigated by limiting purchases to the safest types of investments including \$30.1 million in the California pooled fund (24%), the Local Agency Investment Fund "LAIF", \$58.8 million Federal Agency securities (47%), \$13.4 million Medium-term Corporate notes (11%), \$9.6 million Certificates of Deposit (8%) and other allowable investments including municipal bonds with A or better ratings and supranational securities with AAA ratings.

Liquidity: During the 2020 pandemic, short-term funds were increased to accommodate City operations. This year, short-term investments have been reduced. The investments in LAIF have same day liquidity and were \$6 million dollars lower than the prior year. Other short-term investments were also reduced.

Yield: The average yield, calculated using the custodial account methodology, was 0.93% while the benchmark 2-year T-Bill was 0.14%. This objective is subservient to the priorities of safety and liquidity but is highly desirable because realized earnings will be utilized to fund operations.

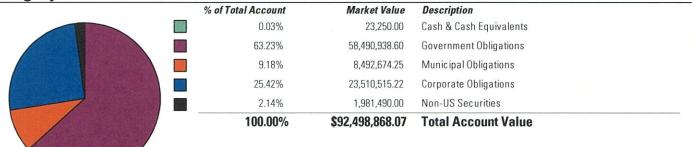
