Recap of Minutes

1) Adam Schwerner called the meeting to order at 5:00 p.m.

2) Minutes of the January 10, 2022, meeting were approved as presented. M/S Kollenda/Wood.

3) Chair's Announcements: None.

- 4) Commissioner and Staff Communications: Michael Ervin noted that the Laguna Beach Arts Alliance Art Star Awards event was scheduled for April 24, 2022, and the City of Laguna Beach was nominated for "Best Arts Program" for the Temporary Art program. Pat Kollenda noted that John Campbell of Laguna Beach Rotary requested an Arts Commissioner speak about arts programming at a future meeting. Staff Poeschl noted the public art collection was being reviewed for restoration and all Heisler Park and downtown sculptures would be cleaned and resealed. Staff Poeschl noted that the proposed temporary installation at City Hall by Gerard Basil Stripling would be reviewed by City Council on January 25, 2022, and, if approved, would be installed on January 27 and 28, 2022. Staff Poeschl noted that the artist-designed bench Tidepool Paddleboard would be reinstalled reinstall at Heisler Park on January 28, 2022. Staff McGregor noted that pre-registrations for Art That's Small were being accepted until March 3, 2022, and artwork drop-off would be Saturday, March 5, 2022, between 9 and 11 a.m. Staff noted design submissions for the 2022 banner competition were being accepted online until March 7, 2022. Staff noted the pick-up date for recently deaccessioned banners was Saturday, February 19, 2022, between 9 and 11 a.m. Staff noted that the installation of the most recent Postcards from Laguna murals was awaiting approval from Frontier Communications.
- 5) **Public Communications:** Mike Tauber presented on behalf of LOCA Arts Education regarding how Cultural Arts Funding grant funds were used in 2021. Jacoby Hickerson and Victor De La Cruz presented on behalf of the Laguna Beach Chamber Singers regarding how Cultural Arts Funding grant funds were used in 2021.
- 6) Items for Discussion and Action:
- A) Youth Art Advisory Board Staff McGregor noted the Commission's action to establish a You Arts Advisory board was delayed in 2021 due to lack of applications. Staff presented the application guidelines for 2022-23 and noted that the appointment period align with enrollment dates for Laguna Beach Unified School District and Laguna College of Art + Design. A motion was made to approve the guidelines as presented. M/S Chauvel/Wood. Yeas: Ballard, Chauvel, Ervin, Kollenda, Mellor, Schwerner, Wood. Noes: None.
- B) <u>Summer Live Music Concerts</u> Staff Poeschl presented the line-up for the 2022 Music in the Park concert series. Staff noted that the performer for July 31, 2022, would need to be replaced due to budgetary constraints. Staff noted the Festival of Arts would be celebrating its 90th anniversary on Saturday, August 13, 2022. Staff

recommended collaborating to provide the musical performance for the event. A motion was made to approve the recommended performers and collaborate with the Festival of Arts to produce a concert on August 13, 2022. M/S Kollenda/Wood. Yeas: Ballard, Chauvel, Ervin, Kollenda, Mellor, Schwerner, Wood. Noes: None.

- C) Friday Flicks at the Forum Staff Poeschl noted that the February 4, 2022screening had been postponed until March 4, 2022. Staff McGregor presented the recommended films. Suzi Chauvel noted concern over the lack of attendance and recommended a fall timeline for the screenings. A motion was made to approve the films as presented and delay the screening dates until fall 2022. M/S Kollenda/Mellor. Yeas: Ballard, Chauvel, Ervin, Kollenda, Mellor, Schwerner, Wood. Noes: None.
- **D)** Public Art Ordinance and Policy Staff Poeschl provided an update of Cultural Planning Group's initial site visit and planned course of action to develop a public art ordinance and policy.
- E) Arts and Economic Prosperity Report Karen Wood noted that Americans for the Arts were going to delay collection of audience questionnaires for the report due to Covid-19 disruptions. Ms. Wood noted that the report would likely not be made available until June 2023. Staff Poeschl noted that Americans for the Arts had offered a discount to participate in the study which allowed for the hiring of additional help to gather audience surveys. Staff noted that the hired individual has been made aware of the delay.

Overview

The City of Laguna Beach's annual Art That's Small at City Hall exhibition is in its 20th year. The exhibit will be installed at City Hall on March 5, 2022 and be open to the public until April 14, 2022. Calls for jurors for the 2022 Art That's Small at City Hall exhibition were sent out to local gallery directors, arts organization representatives and prominent artists.

Summary of the Matter

Jurors will evaluate work based on content, quality and how it fits the theme of the exhibition. Jurors will review the exhibition and convene via virtual conference in March 2022, and select first, second and third place winners as well as any honorable mentions. Awards will be announced on April 7, 2022. In recognition of the 20th anniversary of the program, it is recommended that Mike Tauber, former Arts Commissioner, and founder of the Art That's Small program, be appointed as juror for the exhibition. Title: Marketing Workshop for Artists

Overview

The Arts Commission, in partnership with Americans for the Arts, has previously provided free marketing workshops for artists and arts organizations. The cost to produce a workshop has ranged between \$3,000 and \$5,000. Following the workshops, recordings and materials are made publicly available via the City's website. Workshops typically receive approximately 50 registrations with about 30 attendees per event. The current available funds are \$22,900.

Summary of the Matter

Workshops in February and May 2021 were presented via online webinar due to COVID-19 and restrictions on public gatherings. Commissioners should discuss hosting workshops in 2022, potential dates, presenters, and topic recommendations.

SUBJECT: Temporary Mural Installation on the Third Street Stairs (Item C)

In January 2018, the City Council accepted a donation from Laguna Beach residents Tammie Arnold and Mark Porterfield of \$50,000 for an installation at the Third Street Stairs to celebrate the energetic life of Stanley Alexander. An application was made to the Planning Commission for a Temporary Use Permit for temporary exhibits which was approved on October 2, 2019.

In 2020, the City Council approved a temporary installation on the stairs by artist Beau Stanton. Stanton is an alumnus of the Laguna College of Art and Design and works on large-scale murals. His works have been installed around the United States and his reputation is growing in stature. The mural was painted onto the stairway which has 70 raisers each measuring 58" in width by 6" in height and was paid a stipend of \$25,000 for site preparation and installation.

The installation has been highly successful and has featured in numerous publications and social media. Although the mural is still well maintained, the colors of the mural have faded. The artist has developed another design for installation, which he would use longer lasting paints and sealers. The installation will take a week and will be on display for up to five years or depending on the wear and condition at a cost of \$25,000 available through the donation.

Staff has been in contact with the donors who expressed support of the redesign and expenditure. The design and concept of revamping the installation was also supported by the Public Art Sub-committee consisting of Commissioners Donna Ballard, Suzi Chauvel and Adam Schwerner.

It is recommended that the Arts Commission:


- 1) Approve the design by Beau Stanton for temporary installation on the Third Street Stairs
- 2) Approve the expenditure of \$25,000 available through a donation.

SUBJECT: Special Performances and Events (Item D)

The Arts Commission has approved a number of special performances and events in 2022, in additional to its annual programs that include Circus Bella and a music performance celebrating the Festival of Arts 90th anniversary. The subcommittee consisting of Arts Commissioners Pat Kollenda, Suzi Chauvel and Karen Wood have an additional recommendation for this year's schedule.

The sub-committee is recommending a puppet show performance by Luce Puppet Company on June 14 and November 20, 2022, to celebrate both National and World Children's Day. The mission of National Children's Day is to spend time with children and start new traditions and experiences with World Children's Day promoting togetherness and improvements to the welfare for all children. Two performances would be presented at 11 a.m. and 1 p.m. at either Bluebird Park or Heisler Park at a cost of \$1,500. The performance would be free to attend and accessible to all.

On November 2, 2021, the City Council approved the 2022 performance schedule which included Circus Bella at Bluebird Park. At its last meeting the Commission approved a celebratory 90th concert at the Festival of Arts. All events are free to the public, are accessible to everyone and offers the community a varied cultural experience.

It is recommended that the Arts Commission:

- 1) Approve a performance by the Luce Puppet Company on June 14 and November 20, 2022, as described.
- 2) Recommend the location of the performance at either Heisler Park or Bluebird Park, and.
- 3) Approve the expenditure of \$33,500 for the presentation of the Luce Puppet Company, Circus Bella and the celebratory 90th concert at the Festival of Arts on August 13, 2022, from savings in the Arts Commission Special Programs budget of the Laguna Beach Tourism Marketing District.
