SIDE LETTER OF AGREEMENT

BETWEEN

THE CITY OF LAGUNA BEACH

AND

THE LAGUNA BEACH POLICE AND FIRE MANAGEMENT ASSOCIATION - POLICE UNIT

This Side Letter of Agreement ("Agreement") between the City of Laguna Beach ("City") and the Laguna Beach Police and Fire Management Association ("LBPFMA") - Police Unit is entered into with respect to the following:

WHEREAS, the parties are currently parties to a Memorandum of Understanding (MOU) with a term of July 1, 2021 through June 30, 2024; and

WHEREAS, the City has agreed to provide Juneteenth as a holiday for members of the LBPFMA starting in 2022; and

WHEREAS, the following sets forth the parties' Agreement:

1. The parties agree to amend Article 22 of their MOU as can be seen with the track changes below:

22.0 Holidays

- **22.1** Recognized Holidays: The following holidays shall be observed by the City of Laguna Beach:
 - 1. New Year's Day January 1st
 - 2. Martin Luther King Jr. Day 3rd Monday in January
 - 3. President's Day 3rd Monday in February
 - 4. Memorial Day Last Monday in May
 - 5 Juneteenth June 19
 - 65. Independence Day July 4th
 - 76. Labor Day 1st Monday in September
 - 87. Veterans Day November 11th
 - 98. Thanksgiving Day 4th Thursday in November
 - 109. The day after Thanksgiving
 - 1<u>1</u>0. Christmas Day December 25th

Notwithstanding that the above are the holidays for employees in the unit, if the Police Chief needs the employee to work on any of the above holidays, they will be required to do so.

22.2 Compensation for Holidays: Employees receive nine (9) hours of pay for each of the above holidays. If an employee in the unit is assigned to a work schedule of more than nine hours per day, they must use vacation leave for the hours between nine and their scheduled hours to be paid for the entire holiday. For any holiday on

which a unit member is required to work, they can bank the nine (9) hours as holiday leave. Any holiday leave still banked on the last pay period of June each year will be cashed out to the employee.

22.3 Weekend Holidays: When a holiday falls on a Sunday, the following Monday shall be deemed to be the holiday in lieu of the day observed. If a holiday falls on a Saturday the preceding Friday is the holiday in lieu of the day observed.

For those employees who work an alternate work schedule, *e.g.*, 9/80, when a holiday falls on a regularly scheduled day off, employees shall receive nine (9) hours added to their vacation accrual bank.

- 2. Since Juneteenth (June 19) occurs on a Sunday in 2022, per Article 22.3 of the parties' MOU, the holiday will be observed on Monday, June 20, 2022.
- 3. Per Article 22.2, if any unit member is required to work on Juneteenth in 2022 (June 20, 2022) the nine (9) hours they will bank will be cashed out on the last pay period of June 2022.
