This permit must be made available for inspection upon request by City officials. Permittee acknowledges the following terms and conditions established pursuant to City of Laguna Beach ("City") Municipal Code Section 8.04.010(a)(2)(i), and further:

- Permittee must be in attendance for the duration of the event and is responsible for ensuring that all persons attending the event who consume alcoholic beverages are of legal age to do so according to local and state law. \_\_\_\_\_ Initial required
- This permit is not transferable and is valid only for the date, hours, and location listed on the permit issued. \_\_\_\_\_ Initial required
- Alcoholic beverages must be consumed with a bona fide meal, and any sale of alcoholic beverages is prohibited. \_\_\_\_\_ Initial required
- Consumption of any alcoholic beverage or possession of any receptacle containing any alcoholic beverage that has been opened is not permitted in parking lots, children's play areas, or on any beach. \_\_\_\_\_ Initial required
- Luxury and pop-up picnic business are not permitted. \_\_\_\_\_ Initial required
- Permittee is responsible for the conduct of all attendees of the event. \_\_\_\_\_ Initial required
- The area utilized for the event must be left clean when the event is completed. \_\_\_\_\_ Initial required
- Disruptive or obnoxious behavior or excessive noise shall be prohibited and may result in immediate revocation of the permit and immediate termination of the event for which the permit was issued. \_\_\_\_\_ Initial required
- Groups of 20+ people or longer than 4 hrs in duration must be approved by Laguna Beach Police Department. \_\_\_\_\_ Initial required
- Permit does not guarantee space at the location, and you may not block or rope off pathways. \_\_\_\_\_ Initial required

Permittee further agrees to defend, indemnify and hold the City, its officers, directors, employees, and representatives harmless from and against any and all actions, claims, demands, judgments, attorneys fees, costs, damages to persons or property, penalties, obligations, expenses or liabilities of any kind that may be asserted or claimed by any person or entity (including but not limited to any employee, agent or contractor of Permittee) in any way arising out of or in connection with this Permit or the event carried on by Permittee at the above identified park, or any area to which Permittee has access hereunder, whether or not there is concurrent active or passive negligence on the part of City, and/or acts for which the City would be held strictly liable, but excluding the sole active negligence and willful misconduct of City.
