GENERAL PLAN DESIGNATION AND ZONING: The project site is located within the Residential Hillside Protection (R/HP) and Open Space/Conservation Zones (OSC). Specifically, the project site includes one parcel, with the 26,781 sq. ft. of the parcel within the R/HP zoning designation and 47,135 sq. ft. within the OSC zone. The entirety of the proposed structure is situated within the R/HP zone. The R/HP zoning allows single-family residential structures and uses.

DESCRIPTION OF PROJECT: The proposed project involves the construction of a new single-family residential structure on a vacant lot in the foothills of the City of Laguna Beach. The project site consists of one parcel with a total buildable lot area of roughly 82,819 sq. ft. The proposed project consists of a new three level structure with a total of approximately 10,522 sq. ft. of livable space with related landscape walls, terrace, pool, pool deck, courtyard, and an attached three-car garage.

ENVIRONMENTAL SETTING: The project site consists of one parcel that covers 1.9 acres. The project site currently consists of a vacant parcel, which has been disturbed previously to install underground water tanks. Vegetation on the project site includes trees, shrubs, plants, and untouched soil.
