Location: 935 Laguna Canyon Rd, Laguna Beach

#### Overview

The Cultural Arts Department has received an application from the Sawdust Art Festival requesting the replacement of the existing mural with the design "Harmonic" by Sawdust Art Festival exhibitor Tara Luther. The mural will be painted with latex and acrylics and coated with an anti-graffiti sealant. The mural will measure 50' in length by 8' in height and will be on exhibit through spring 2024. The festival has presented a pedestrian mitigation plan for the mural installation.

Two fluorescent LED photocell lights will be mounted above the mural to provide lighting with sensors when day transitions to night throughout the duration of the installation. Proposed lighting shall minimize glare and light spillage onto Frontage Road and Dark Sky compliant.

Tara Luther has been exhibiting her work since 2013 and has been a Sawdust Art Festival exhibitor starting in 2021. Her experience with large-scale work is reflected in the enclosed application. The imagery of "Harmonic" reflects the harmony of the natural world, culminating in the symbolic gesture of one hand sharing natural gifts and talents, while the other hand reaches out to receive them.

If approved, Staff will prepare a memorandum to the City Council and Planning Commission on behalf of the City Manager. Upon review, members of the City Council or Planning Commission have 10 days in which to appeal the Arts Commission decision. If appealed, the application would be reviewed by the Planning Commission.

### Recommendation:

The Public Art Subcommittee, consisting of Commissioners Donna Ballard, Suzi Chauvel, and Adam Schwerner, has reviewed the application and recommended approval of the mural installation. Staff is seeking Arts Commission approval of the new temporary mural.

## City of Laguna Beach Municipal Code

## **Chapter 25.54 Sign Regulations**

"Mural" means an original work of art that is applied or attached to an exterior wall. (At the discretion of the arts commission a mural may be considered a wall sign, if it contains words, logos, trademarks or graphic representations of any person, product or service that identify a business.)

## 25.54.024 Murals.

- (A) Murals shall conform to the design standards and permit procedures outlined below; except that murals proposed in compliance with Chapter 1.09 (Art in Public Places) shall be governed by the design standards and permit procedures of that chapter, and mural proposals which are considered to be wall signs shall conform to the design standards applicable to wall signs. Signature(s) of the artist(s) shall be allowed and limited to a maximum of two square feet.
- (B) The following procedures shall govern the approval of mural proposals:
  - (1) Applications. Applications for mural permits shall be submitted to the department of community development on an approved application form and shall be accompanied by the following: a site plan showing the lot and building dimensions and indicating the proposed location of the mural; a scale drawing and color photo of the building showing the proposed size and placement of the mural; a colored drawing of the proposed mural; and the proposed maintenance schedule.
  - (2) Arts Commission Review Required. The arts commission shall review and approve all proposed mural applications. If the proposed mural contains words, logos, trademarks or graphic representations of any person, product or service that identify a business, the arts commission shall determine whether the proposal is a mural or a wall sign.
  - (3) Heritage Committee Review Required. If a mural is proposed on a historic structure identified on the city's historic resources inventory and/or city's Historic Register, the heritage committee shall review and make a recommendation regarding the mural proposal prior to the review of the arts commission.
  - (4) Additional Review. All proposed murals located in the downtown may be appealed to the planning commission by a member of the planning commission or city council for review and approval.
  - (5) Criteria. In addition to the design criteria set forth in this chapter and Section 25.05.040 for design review, the following criteria shall be considered in the review of mural applications:
    - (a) Visual Enhancement. The proposed mural has attributes that enhance the site;
    - (b) Artistic Excellence. The proposed mural exemplifies high artistic quality of original artwork;
    - (c) Public Safety. The proposed mural does not create a public safety issue;
  - (6) Lighting. Proposed lighting of murals shall minimize glare and/or light spillage onto the public way or adjacent properties.
  - (7) Long-term Maintenance and Removal. The mural shall be maintained in good condition for the life of the mural according to the maintenance schedule and responsibilities approved by the arts commission. The removal or deaccession of murals shall comply with the deaccession policy established by the city council of Laguna Beach. (Ord. 1499 § 1, 2009; Ord. 1408 § 1 (Atth. A (part)), 2002).



Title: 935 Laguna Canyon Road (Sawdust Art Festival) Temporary Art Installation

Location: 935 Laguna Canyon Road., Laguna Beach

## Overview

During the 2020 Pandemic, the Arts Commission and Cultural Arts Department, with funding from the Wayne Peterson Fund through the Laguna Beach Community Foundation, created a grant program titled "Fostering Creativity in a Time of Crisis." Laguna Beach artist Nevada Silva submitted his design proposal and was awarded a grant.

Nevada Silva is proposing to fulfill the display requirement for his grant with a temporary sculptural mural installation on the Sawdust Art Festival facing Laguna Frontage Road. This location is highly visible to residents and visitors during the summer festival season. The Sawdust Art Festival board has approved the installation, which will be on exhibit from June 1, 2023, to September 4, 2023. The installation measures 4 feet wide by 6 feet tall with a central planted section, which will include species of succulents. The planting will be maintained for the duration of the exhibition by Sawdust Art Festival grounds staff in addition to the artist.

Nevada Silva has been an exhibitor at the Sawdust Art Festival since 2015 and specializes in wall-mounted metal sculptures with built-in plant design elements.

## Recommendation

Staff recommends approval of a temporary sculptural mural installation at 935 Laguna Canyon Road on the façade of the Sawdust Art Festival by Nevada Silva from June 1, 2023, to September 4, 2023.

**Title:** 2023 Council Chamber Banner Competition

**Location:** City Hall, 505 Forest Avenue

## Overview

The City of Laguna Beach's Council Chamber Banner Competition is an opportunity for local artists to design and create interior single-sided banners which are displayed temporarily in the City Council Chambers at Laguna Beach City Hall, 505 Forest Avenue. The most recent Council Chamber banners designs were created in 2018.

## **Summary of the Matter**

The competition is typically held every 4 years. A competition was held in 2022, however, no designs were selected by the Commission. Staff is recommending holding a Council Chamber Banner competition in 2023. The Arts Commission has budget and material for up to four (4) banners to be created. New Council Chamber Banners will provide an additional public arts opportunity for local artists. Designs will be accepted via online submission to SlideRoom. The guidelines have been updated for 2023 and reflect the scheduled dates for the competition.

### Recommendation:

It is recommended that the Arts Commission approve the schedule and guidelines as presented.

## **Council Chamber Banner Competition**

## Description

The City of Laguna Beach Council Chamber Banner Competition is a project of the Arts Commission. Selected artists are provided with banner material on which to paint original artwork. The completed banners are displayed in the City of Laguna Beach Council Chambers.

## Eligibility

Open to artists 18 years of age or older who live, work, or exhibit in Laguna Beach (proof required).

## **Entry Requirements**

Please submit a color design drawn to scale (15 in. x 4 ½ in.) of your banner. Designs should be hand-drawn or painted, demonstrating ability and familiarity with materials. Bright colors are suggested, and a community celebration theme encouraged. Religious symbols are discouraged. For judging purposes please do not sign the front of your submitted design. Artists may submit a maximum of two (2) designs.

Selected artists are provided with a vertical 10 ft x 3 ft. banner. Actual banners may vary slightly in size. Allow a variance of 10% in your design. Banners must be painted on one side using acrylic paint.

### **Deadlines and Important Dates**

Sent 11 2023	Arts Commission will review and select the designs

Oct. 16, 2023 Completed banners must be delivered to City Hall.
Oct. 24, 2023 Winners will be recognized at the City Council meeting.

### **Jurying Process**

The seven members of the City of Laguna Beach Arts Commission review designs anonymously for creativity and visual impact. Commissioners vote by ballot, which are tallied, and up to four (4) designs are selected by a majority motion.

## **Compensation / Award**

Completed banners will be awarded an \$900 honorarium. The completed banner and designs become property of the City of Laguna Beach and will be displayed when and where the City desires.
