Artist Statement

I have been creating sculptures that express the "Strength of Human Will" for over 33 years encompassing 14 public art commissions and countless exhibitions, some of which have been sponsored by MGM Mirage, Cirque du Soleil and General Motors.

All of my sculptures are one-of-a-kind original bronze (with no series or additions), which keeps the integrity of the work and value to any city public art collection.

ArtLofts Laguna Beach has been an undertaking involving so many people that have contributed to this project being built. It has taken over 15 years to get this 28-unit work/live facility approved and built. The journey to obtain entitlements for ArtLofts has had its challenges.

There were highs and lows, uncertainty with unimaginable experiences. It is this ebb and flow that has taken us on this journey of life that it would be fitting to create a sculpture that mimics a flowing ribbon in the wind. Like life, it can float gracefully during good times and fly out of control during turbulent times, ups and downs, ebb and flow.

"Journey" will mimic all the hard work and experiences that seemed to be blowing in the wind for over 15 years. The sculpture will reflect upon the cool ocean breezes that flow out through the canyon every day.

My work is highly stylized and unique to my own technique in the art world. With my extensive experience as an artist and innovator of the bronze medium that works with the environment and the settings, this sculpture will be well suited for this environment.

It is my goal to create sculptures that work in unity and give the area a sense of place that encourages visitors to explore.


