RESOLUTION NO. 21.059

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAGUNA BEACH SETTING MAXIMUM SOLID WASTE SERVICE RATES AND REPEALING RESOLUTION NO. 19.032 AND ALL RESOLUTIONS INCONSISTENT HEREWITH

WHEREAS, Chapter 7.18 of the Laguna Beach Municipal Code imposes a solid waste service rate and provides in Section 7.18.030 that the amount of said charge shall be determined by Resolution of the City Council; and

WHEREAS, the City has entered a Franchise Agreement for solid waste services and pursuant to said Franchise Agreement the Council has established maximum rates for solid waste services and a methodology for adjusting such maximum rates; and

WHEREAS, the State of California has adopted Senate Bill 1383 (SB 1383), Short-lived Climate Pollutants, that establishes methane emissions reduction targets in a statewide effort to reduce emissions of short-lived climate pollutants, and provides CalRecycle the regulatory authority required to achieve the organic waste disposal reduction targets of 75% reduction of the 2014 level of statewide disposal of organic waste by 2025; and requires jurisdictions to provide organic waste collection to all organic waste generators, including residents, businesses, City facilities, and large event venues; and

WHEREAS, at its May 18, 2021 meeting, the City Council of the City of Laguna Beach authorized a State Mandated Residential Customer SB 1383 Organics Program and the increase in solid waste service charges will serve to fund the organics program; and

WHEREAS, the City Council further finds and determines that revenues from the service charges will not exceed the funds required to fund the service; revenues from the service rates will not be used for any purpose other than that for which the rates are imposed; the amount of the rates imposed upon any parcel will not exceed the proportional cost of the service attributable to the parcel; and the services for which the rates are imposed are used by, or are immediately available to the owners of affected parcels.

NOW, THEREFORE, the City Council of Laguna Beach hereby resolve, and orders as follows:
