## Wedding Permit Application – FY 23-24

Crescent Bay Point Park \$517 and All Other Parks & Beaches \$416

- This permit allows a two consecutive hour use of the designated permit location.
- Memorial Day to Labor Day Beach weddings allowed at four locations only.
  - $\circ$   $\;$  Diver's Cove, Picnic Beach, Rockpile Beach, and North Main Beach
- We do not permit weddings for Crescent Bay Point Park on Sundays or holidays.
- You must have the permit with you while utilizing the site.
- Requested changes to the permit (date, time, or location) may result in a \$10 processing fee.
- Application fee is non-refundable.
- VISA, MasterCard, Discover, Cash, and Check (only if received two weeks or more prior), accepted.
- High tide must be considered when booking the beach. Permits are not issued around high tide or after sunset.
- Permit applications must be received at least two business days prior to the requested date for consideration and processing.

## Rules and Regulations for the NON-EXCLUSIVE right to use a City Park or Beach

- The wedding site must be always accessible to the public. \_\_\_\_\_\_ Initial required
- No blocking of pathways or roping/taping off any area of the park is allowed. \_\_\_\_\_\_\_Initial required
- All parking restrictions must be obeyed. \_\_\_\_\_\_Initial required
- Decorations are allowed (excluding loose flower petals) but must be removed by end of permit time. Use only string or ribbon to hang decorations. No nails, staples or tape can be used.
- No glass of any kind on any of the beaches or parks. \_\_\_\_\_ Initial required
- No smoking on the beaches or in the parks. \_\_\_\_\_\_\_\_\_Initial required
- No tables or chairs (medical exceptions permitted). \_\_\_\_\_\_Initial required
- No archways or structures, including large letters and balloons. \_\_\_\_\_ Initial required
- No animal drawn vehicles are permitted. \_\_\_\_\_\_\_Initial required
- No alcoholic beverages, including champagne toasts, are permitted. \_\_\_\_\_\_Initial required
- No open flames (includes candles, lanterns, tiki torches, etc.) are permitted. \_\_\_\_\_\_\_\_Initial required
- No rice, birdseed, confetti and/or flower petals (real or artificial) are permitted. \_\_\_\_\_\_Initial required
- Maximum capacity, including wedding party and all guests at the Crescent Bay Point Park, Gazebo, and Monument Point is **50 people**. Maximum capacity for other locations is **95 people**.
- There are no refunds for cancellations or inclement weather.
- Do you have a wedding planner or coordinator? Yes \_\_\_\_\_ or No \_\_\_\_\_
  - It is your responsibility to inform them of all rules and regulations. \_\_\_\_\_ Initial required
- Once payment is received, your permit will be emailed to you. \_\_\_\_\_\_Initial required
