**PROJECT DESCRIPTION:** Zoning Ordinance Amendment 22-0497, Local Coastal Program Amendment 22-0498, and General Plan Amendment 22-0499 to amend portions of the Laguna Beach Municipal Code and General Plan generally pertaining to the regulation of oceanfront development with the establishment of a Bluff Overlay District, and methodologies for calculating major remodels. The Planning Commission will receive an introduction to the draft ordinance on April 6<sup>th</sup>, and final recommendations to the City Council will be collected at a subsequent hearing.

**COASTAL ZONE:** This project is located within an appealable area of the Coastal Zone.

CEQA: This project is categorically exempt pursuant to the California Environmental Quality Act Guidelines, Sections 15061(b)(3) (no possible significant effect on the environment), 15307 (actions by regulatory agencies for protection of natural resources), and 15308 (actions by regulatory agencies for protection of the environment). A Local Coastal Program Amendment is required because all amendments to the City's certified Local Coastal Plan require Coastal Commission approval. Public Resources Code Section 21080.5, a provision of the California Environmental Act (CEQA), and Section 15265(c) of the State CEQA Guidelines shift the burden of CEQA compliance to the California Coastal Commission in connection with the preparation or amendment to a Local Coastal Program (LCP). The Coastal Commission's LCP review and approval procedures have been found to be functionally equivalent to the environmental review process.
