\_\_\_\_ I understand that the City of Laguna Beach has an exclusive franchise agreement with Waste Management of Orange County. Use of containers provided by another solid waste hauler is prohibited in accordance with Laguna Beach Municipal Code Section 7.16.220 and 7.16.230. (Option 1)

\_\_\_\_ I understand the use of containers owned by a licensed construction or demolition contractor or subcontractor are only permitted if used as part of the scope of work and that the containers are properly labeled with the contractor or subcontractor's company's name. (Option 2)

\_\_\_\_ I understand it is prohibited to use residential trash, recycling, and/or green waste carts for C&D debris waste generated from this project. The property owner will be charged a contamination fee by Waste Management, and if applicable, a replacement fee for damaged carts.

\_\_\_\_ All subcontractors on the project must be notified of the project's Waste Disposal Plan.
