Title: Sunset Serenades

Location: Heisler Park Amphitheater

Overview

Sunset Serenades is a free public concert series held each Friday evening in May and September with World Music held in June at the Heisler Park Amphitheater. Spring concerts take place from 6:30 p.m. to sunset. On September 11, 2023, the Arts Commission approved spring 2024 concert dates for Sunset Serenades.

In 2023, the City partnered with Pacific Symphony to present their "Symphony on the Go!" program as an additional concert for the fall season. Pacific Symphony informed staff that they are continuing their program in 2024 and has offered to partner for another concert.

Summary of the Matter

The Sunset Serenades performances are curated with the help of local musician Jason Feddy. The following schedule is recommended for May and June 2024:

Pacific Symphony has offered to partner for another "Symphony on the Go!" concert. Staff is planning for October 4, 2024, as the performance date, which would directly follow the fall 2024 Sunset Serenades season. Pacific Symphony would provide musicians to perform at no cost to the City. The City would need to provide audio reinforcement at a cost of \$1,000.

Recommendation

It is recommended that the Arts Commission take the following actions: 1) Approve the Sunset Serenades performer schedule as presented; 2) Approve partnering with Pacific Symphony to present a "Symphony on the Go!" concert on October 4, 2024; 3) Allocate \$1,000 from savings in the Arts Commission Special Programs budget to fund audio services for the "Symphony on the Go!" concert.

SUBJECT: Donation for Temporary Sculpture Installation (Item B)

The Arts Commission has received interest from members of the community in contributing financial donations to Arts Commission Special Programs. Several temporary art installations outside City Hall have been facilitated by private funds by individual residents providing crucial support of local artists in the community.

Laguna Beach residents Mark Porterfield and Steve Chadima have offered a generous donation of an amount of \$24,000 for the recently approved temporary installation of the sculpture "Epicenter" by Laguna Beach artist Casey Parlette. This donation covers the entire cost of the installation.

Accepting the donation would greatly benefit the Commission's programming and aligns with Cultural Arts Plan of promoting arts and continuing to enrich the community through artistic expression. The donation will enable the Commission to sustain and expand programming and demonstrates the support the community has in fostering creativity and artistic engagement.

The necessary action, if approved, would be for the Arts Commission to recommend the City Council accept the donation to facilitate the temporary installation as described and for the Mayor to sign a letter of appreciation to the donor. The City will acknowledge the donation in notifications about the program and on-site artist information noting "this installation is funded by Laguna Beach residents Mark Porterfield and Steve Chadima". The installation is tentatively scheduled for early 2025.

SUBJECT: 2024 – 2025 Arts Commission Special Programs Budget of the Laguna Beach Marketing and

Tourism District (Item C)

The estimated revenue available in the Arts Commission Special Programs Budget of the Laguna Beach Tourism Marketing District in FY 2024-2025 is \$319,800, a decrease of \$2,700 from the current financial year. To sustain the same level of programming and commitments made by the Commission the changes include Innovation Grants for Artists be a biennial program, Chamber Banners undertaken as necessary and consideration of funding larger projects through savings. The budget also includes three additions, a budget for filming the Commissions programming as recently seen in the banner video, activating public art with community events and a digital public art data base which it the recommendation by the Cultural Planning Group for the adoption of the Public Art Policy.

Attached is a draft of the detailed budget prepared by staff and reviewed by the sub-committee consisting of Arts Commission Chair Ballard, Vice-Chair Schwerner and Treasurer Ervin. The budget includes increases in costs and additional programming introduced and approved by the Commission to expand the wealth of cultural experiences for the community and overnight guests.

It is recommended that the Arts Commission discuss and approve the budget with any suggested revisions or additions.
