

Shopper Parking Permit Reference Sheet

Who is eligible for this permit? **Laguna Beach residents only**

When is it valid? **August 1, 2024 - July 31, 2026 (Permits are valid for 2 years)**

Permit Uses:

All City meters are eligible (Must follow allotted time indicated on meters)

- **Exception:** Permits not valid at meters on Laguna Canyon Road north of Forest Avenue and the adjacent Frontage Road during the summer festival season (Late June to Labor Day)
- **Exception:** Permits are always valid at meters adjacent to the dog park.

Permits allow for parking at eligible City Pay Parking Lots without depositing payment into the ticket machine for up to 3 hours. **The following City Pay Parking Lots are eligible:**

- **Exception:** Permits are valid at Act V/ Lot 16 parking lot during summer festival season (Late June to Labor Day)
- **Exception:** Permits are NOT valid at Lot 12, this is an employee only parking lot.
- **Exception:** Permits are valid at Lots 10 & 11 only during non-summer season (Day after Labor Day to late June)

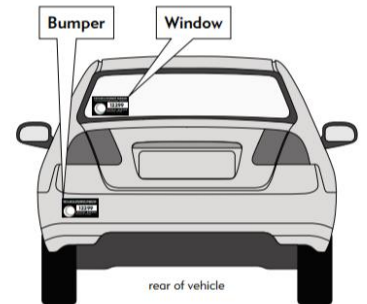

Permit Requirements:

Acceptable forms for proof of residency includes a copy of **ONE** of the following:

- ✓ **DMV Registration** - Residents applying for a third and/or fourth permit must provide a copy of all 3 or 4 vehicle DMV registrations with the application.
- ✓ **Driver's License/State ID Card**
- ✓ **Rental/Lease Agreement**
- ✓ **Utility Bill (gas, electric, water, or cable) showing name and service address**
- ✓ **Pre-printed check**

PLACE PERMIT ON LEFT REAR Bumper OR LOWER
LEFT CORNER OF REAR WINDOW
MUST BE VISIBLE & PLACED ON OUTSIDE OF VEHICLE



Addresses that are P.O. Boxes or commercial postal locations will NOT be accepted.

Permit Cost:

The cost of a Shopper Parking Permit is:

- ✓ **\$80 each for the first two permits**
- ✓ **\$150 each for the third and fourth permits**
 - Must provide copies of ALL DMV registrations when applying for 3rd & 4th permits
- ✓ Each address is limited to a maximum of **FOUR** Shopper Parking Permits.
- ✓ Permits are prorated beginning August 1, 2025.
- ✓ Fees are NON-REFUNDABLE and permits are NOT TRANSFERRABLE from one vehicle to another.
- ✓ **Purchasing a new vehicle:** Must Remove permit from old vehicle and bring to City Hall/Cashier for **REPLACEMENT** permit for \$5.
