- 1) A written description of the alleged safety hazard or view and/or sunlight impacts created by vegetation that is located within the front, side or rear yard setbacks that exceed the maximum fence height(s). This summary shall describe the extent to which the safety, view and/or sunlight access has been diminished by vegetation. The summary shall include the desired height of the alleged non-conforming vegetation.
- Photographic prints or color copies of photos, taken from the claimant's property clearly illustrating the alleged safety hazard and/or view and/or sunlight impacts. All photographic documents must be submitted on 8½ X 11 paper and in color.
- 3) A plot plan detailing the property boundary, adjacent streets and alleys, and the location of all vegetation alleged to cause the safety hazard and/or view and/or sunlight obstruction.
- 4) A radius map identifying the location of the claimant's property to show that the vegetation owner's property lies within 100 feet of the claimant's property.
- 5) Upon request from city staff, the claimant must submit a public noticing list and a set of addressed envelopes for all property owners within a 100-foot radius of the vegetation owner's property. The addressed envelopes shall include the City of Laguna Beach return address and the assessor's parcel number on each address label. The list shall be compiled from the latest equalized assessment rolls and submitted to the City directly from a professional listing service.
- 6) Submit a \$1,048 application fee.
- 7) It is recommended that the claimant attend the public hearing at which this request will be considered.
